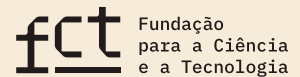

## CALL FOR PAPERS ABSTRACTS:

Abstracts must contain:



**Title of the communication** (centered at the top of the page, Times New Roman font, size 12, bold);

**Name and surname of the author(s)**, below the title, at left;

**Affiliation and email address**;

**Communication summary**: minimum 1 and maximum 2 pages;

**Abstract content**: Object of analysis; Research objective; Research Methodology; Main conclusions; Keywords separated by semicolons; list of the used bibliographic references;

**Font**: Times new roman, size 12; line spacing 1.5;

**The proposal must be accompanied by a brief curriculum vitae** (maximum 150 words);

**Accepted languages** are Portuguese, Spanish and English;

The selected full texts will be published in the Congress Proceedings. For this purpose, they must comply with the following style rules:

### **GRAPHIC APPEARANCE:**

**Body of the text:** Times New Roman font, size 12, space 1.5; 1st line indent 1.5);

**Footnotes:** Times New Roman font, size 10, single spaced;

**Bibliographic and jurisprudential citation** in a footnote at the bottom of the page;

**Bibliographic list** at the end of the text.

### **CITATIONS:**

**Citations in footnote according to the model:** Author (year), p.

**Bibliographic enumeration at the end of the text according to the model:** SURNAME AUTHOR, Other Names (year). Title, edition no. City: Publisher.
